A very comprehensive Policy Statement has been adopted thanks to our Governance representative Mark Schultz.

A Memorandum of Understanding between BBGF and the City of Ballarat has been developed, thanks to Peter Wilson for assistance in formulating the document it is now signed and in place.

Aspiration to develop a Horticultural Apprentice program for our Gardens is becoming a reality thanks to a generous proposition from two Friends donors, it is hoped that this will remain an objective of BBGF into the future.

An electronic Donation card tap point facility has been installed in the BBG Conservatory, proving to be a good source of income until closure due to COVID, thanks to BBG Freinds President Robert Selkirk for assistance with installation of this facility.

During an extraordinarily busy financial year our thanks to Daina MacLeod who has kept our financial records with great professionalism.

Project funding within our Gardens is of high priority, the Fernery redevelopment being of major interest. The BBGF supported in principle the application to Botanic Gardens Victoria Grants program for Landscape funding of Fernery Stage one. Stage two development yet to be finalised and discussion with the City of Ballarat continues.
